

After-sales guarantee for Irish distribution boxes



Overview

I checked out the Consumer Act 2022 and it confirmed that there is no such thing as a 6 year warranty. Instead, under Irish consumer law, you have up to six years from the date of purchase to seek remedies if a product is faulty or not as described. A manufacturer's guarantee is a contractual undertaking, commonly offered, given or sold with the goods. These laws aim to: By law, sellers or suppliers (known as 'traders') must treat you fairly, for example, by making sure products and services are safe and of a high standard. While a buyer's primary contractual rights are usually against the retailer, the law may also provide remedies against manufacturers, distributors and importers in certain. When you sell a good or a service to a consumer online or via other means of distance communication (by telephone, mail order) or outside a shop (from a door-to-door salesperson), the consumer has the right to return the item or cancel the service within 14 days.

The Distributor may not without the Supplier's prior written consent make any promises or guarantees about the relevant goods and/ or services beyond those contained in the promotional material

Guarantees and Warranties

The business should offer a repair, replacement or refund whether you have a guarantee or warranty or not, even if the guarantee or warranty has expired. Find more information in our faulty goods section.

Guarantees on goods bought in the EU

The 2-year guarantee period starts as soon as you receive your goods. If a defect becomes apparent within 1 year of delivery, you don't have to prove it existed at the time of delivery.
