

Distance regulations for distribution boxes at all levels



Overview

OSHA and the National Electrical Code (NEC) specify the minimum clearance distances required around electrical panels. These include a depth of 36 inches, a width of 30 inches, and a height of 78 inches. Distribution box and switch box should not exceed 30 meters. Generally, distribution boxes can. The main distribution box shall be located in the area close to the power supply; the distribution box shall be installed in the area with relatively concentrated electrical equipment or load; the distance between the distribution box and the switch box shall not exceed 30m;.
